To the best of my knowledge, he/she/they are in good physical condition and fully able to participate in this Event. I acknowledge and accept that the Event is a physically challenging obstacle course which does involve risks. I am fully aware of the risks and hazards connected with the participation in this Event, including physical injury or even death, and hereby elect to voluntarily be responsible for named child(ren) in said Event, knowing that the associated physical activity may be hazardous to them and their property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by listed child(ren), or loss or damage to property owned by them, as a result of participation in this Event.

I agree listed child(ren) will wear all safety system including but not limited to helmet, harness, safety line, karabiners and pulleys and that the safety system will remain connected to the safety cables provided by the Company at all times. I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, Maine Adventure Courses, LLC, it's officers, servants, agents, and employees from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by listed child(ren), or to any property belonging to them, while participating in physical activity, or while on or upon the premises where the event is being conducted.

This Release and Waiver of Liability, Assumption of Risk, and Agreement shall be binding upon my heirs, personal representatives and assigns, and me. Should I or my successors assert a claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are financially adjudged liable on such claim for willful and wanton negligence. I agree that the Release of Liability extends to all acts of negligence by the releasees, is intended to be broad and inclusive as is permitted by law, and it shall be governed and construed under the laws of the State of Maine.

In signing this release, I acknowledge and represent that I HAVE READ THE FORGOING Waiver of Liability, UNDERSTAND IT AND SIGN IT VOLUNTARILY as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreements have been made; and I EXECUTE THIS RELEASE FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. I FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
